# SECOND DRAFT BY-LAW NO. 1441-14 TO AMEND ZONING BY-LAW NO. 1441 WITH RESPECT TO SETBACKS, THE COVERAGE RATIO AND THE FLOOR AREA RATIO IN ZONE C-211

**WHEREAS** notice of motion was given on February 20, 2024 and the draft by-law was filed at the same council meeting;

# ON ..., 2024, COUNCIL ENACTED THE FOLLOWING:

- 1. Specifications grid of the zone C-211 of Zoning By-law No. 1441 shall be amended:
  - (1) by adding, under "IMPLANTATION DES BÂTIMENTS", opposite « AVANT MINIMUM (mètres) », the following note: "(1) The minimum front setback is 10 metres on the Rockland Road side and 7.5 metres on the Brittany Avenue side.";
  - (2) by replacing, under "IMPLANTATION DES BÂTIMENTS", opposite "• LATÉRALES TOTALES MINIMUM (mètres)", the number "20" by the number "10";
  - (3) by replacing, under "RAPORT", opposite "• COEFFICIENT D'EMPRISE AU SOL (C.E.S.) MINIMUM/MAXIMUM", the numbers "0,20 / 0,35" by the numbers "0,1 / 0,35";
  - (4) by replacing, under « RAPORT », opposite « COEFFICIENT D'OCCUPATION DU SOL (C.O.S.) MINIMUM/MAXIMUM », the numbers « 0,20 / 0,70 » by the numbers « 0,1 / 0,70 ».
- 2. This by-law shall come into effect according to law.

BY-LAW NO. 1470 CONCERNING THE RATES FOR THE 2024 FINANCIAL YEAR, FOR THE PURPOSE OF ALLOCATING THE FINANCIAL RESERVE TO FINANCE MAJOR EXPENDITURES AND THE REPLACEMENT OF THE ROYALMOUNT FOOTBRIDGE

**ADOPTION PROCEDURE SUMMARY** 

NOTICE OF MOTION AND FILING: FEBRUARY 20, 2024 ADOPTION OF THE BY-LAW: MARCH 19, 2024 COMING INTO EFFECT: 2024

**WHEREAS** a municipality may impose a specific rate structure in accordance with the *Act respecting municipal taxation* CQLR, chapter F-2.1;

**WHEREAS** the Royalmount Pedestrian Walkway Agreement was approved by Council resolution no. 21-10-05 on October 7, 2021 (the "Agreement");

**WHEREAS** the agreement concerns the construction of a footbridge located over Décarie Boulevard and connecting, among others, the Royalmount Project site to the De la Savane metro station so as to provide access to pedestrians, bicycles and persons with reduced mobility (the "Footbridge");

**WHEREAS** the Footbridge shall be accessible to the public and shall constitute a municipal infrastructure of Town of Mount Royal and a pedestrian public way;

**WHEREAS** under the Agreement, all current construction, maintenance and upkeep expenditures for the Footbridge are assumed exclusively by the owners of some of the taxable immovables located in the Project;

**WHEREAS** under the Agreement, all expenditures related to major repairs and the replacement of the Footbridge are assumed exclusively by the owners of some of the taxable immovables located in the Project;

**WHEREAS** a financial reserve to finance major expenses and the replacement of the Royalmount footbridge was created, by the Municipal Council, on December 14, 2023, in order to provide a contingency fund for the financing of said expenses;

**WHEREAS** notice of motion was given on February 20, 2024, and the draft By-law was filed at the same Council meeting;

# ON MARCH 19, 2024, COUNCIL ENACTED THE FOLLOWING:

1. The purpose of this by-law is to establish the rates for fiscal year 2024, in order to provide funding for the financial reserve dedicated to financing major and replacement expenses for the Royalmount footbridge.

# TAX

- 2. In order to provide for the endowment of the financial reserve for the financing of major expenses and the replacement of the Royalmount footbridge, it is by the present by-law imposed and it will be levied annually, on all taxable immovables located in the tax basin described in Schedule "1 " attached to the present by-law to form an integral part hereof, a special tax at a sufficient rate based on the surface area of these taxable immovables, as it appears on the assessment roll in effect each year.
- 3. For fiscal year 2024, the rate imposed is \$1.23 for each square meter of taxable property.

# INTEREST RATES, PENALTIES, DUE DATES AND OTHER TERMS OF PAYMENT

- 4. Interest at the rate of 10% per annum is applied to any amount due to the Town, including tax arrears, calculated day-to-day from the due date.
- 5. By virtue of section 250.1 of the *Act respecting municipal taxation*, a penalty shall be added to the amount of due 2024 municipal taxes and transfer duties in arrears. The penalty is established at a half percent (0.5%) of the outstanding principal for every whole month following the expiry, up to five percent (5%) per annum. The date of expiry is the day on which the tax becomes payable.
- 6. The tax as provided under section 2, is entirely due on the 30<sup>th</sup> day following the mailing of the bill by the Town. Nonetheless, at the option of the debtor, the method of payment may be as follows:
  - 1) if the account is less than \$300: in a lump sum, on the 30<sup>th</sup> day following the mailing of the bill by the Town;
  - 2) if the account is \$300 or more, the payment will be at the choice of the debtor as follows:
    - a) in a lump sum on the 30<sup>th</sup> day following the mailing of the bill by the Town;
    - b) in two (2) equal instalments: the first on the 30<sup>th</sup> day following the mailing of the bill by the Town and the second on the 90<sup>th</sup> day following the last day where can be done the previous instalment.
- 7. Where a tax or a compensation supplement is payable after an alteration to the assessment or collection roll, the supplement is payable as follows:
  - if the amount due is less than \$300: in a lump sum, no later than the 30<sup>th</sup> day after the account is mailed by the Town;
  - 2) if the account is \$300 or more, the payment will be at the choice of the debtor as follows:
    - a) in a lump sum, no later than the 30<sup>th</sup> day after the account is mailed by the Town:
    - b) b)in two (2) equal instalments: the first, no later than the 30<sup>th</sup> day after the account is mailed by the Town, and the second, no later than the 90th day after the last day on which the first instalment may be paid.
- 8. Where no payment is made by the date specified in this by-law, only the instalment due is immediately payable.

# **ADMINISTRATIVE CHARGES**

 By virtue of section 478.1 of the Cities and Towns Act (CQLR, chapter C-19), effective January 1<sup>st</sup>, 2024, the administrative charge claimed for payments refused by the drawee on municipal tax accounts, water accounts and all other accounts owing to the Town of Mount Royal is established at \$25 10. To carry out procedures for the sale of immovables for non-payment of taxes, the Town may charge the sum of \$200, per matricule number, for any immovable appearing on the list of immovables to be sold that is submitted to the Town Council.



# ADOPTION OF BY-LAW NO. E-2409 TO AUTHORIZE CAPITAL EXPENDITURES AND A LOAN OF \$2,000,000 FOR SEWER INFRASTRUCTURE WORK

NOTICE OF MOTION AND FILING: MARCH 6, 2024
ADOPTION OF BY-LAW: MARCH 19, 2024
COMING INTO EFFECT: ....., 2024

**WHEREAS** notice of motion for this by-law was given on March 6, 2024 and the draft by-law was filed at the same council meeting;

CONSIDERING section 544 of the Cities and Towns Act (CQLR, Chapter C-19);

WHEREAS the loan provided by this by-law covers capital expenditures;

**WHEREAS** under the second paragraph of section 544 of the Act, the Town may adopt a loan by-law for the purpose of capital expenditures mentioning the object of the by-law only in general terms and indicating only the amount and maximum term of the loan;

**WHEREAS** Council deems it appropriate to exercise the power granted by the second paragraph of section 544 in the case of this by-law;

# ON ......, 2024, COUNCIL ENACTED THE FOLLOWING:

- 1. Council shall be authorized to spend \$2,000,000 in capital expenditures on stormwater retention structures.
- 2. In order to pay the expenses mentioned in this by-law, Council shall be authorized to borrow \$2,000,000 over a period of twenty (20) years.
- 3. Council shall annually appropriate, during the term of the loan, a portion of the Town's general revenues to provide for expenses incurred for interests and the reimbursement in capital of the loan's annual maturities, the whole in accordance with section 547 of the *Cities and Towns Act*.
- 4. In the event that the amount of an appropriation authorized by this by-law is higher than the amount actually spent with regards to such appropriation, Council shall be authorized to make use of this surplus to pay any other expenses ordered herewith and for which the appropriation was not sufficient.
- Council shall apply, to reduce the loan authorized herewith, any contribution or grant that may be given for the payment of part of all of the expenses herein mentioned.

Council shall also apply to the payment of part or all of the debt service any grant payable over several years. The repayment period for the loan corresponding to the grant amount shall be automatically adjusted to the period established for payment of the grant.

6. This by-law shall come into effect according to law.

**WHEREAS** notice of motion was given on March 19, 2024 and the draft by-law was filed at the same council meeting;

# ON ....., 2024, COUNCIL ENACTED THE FOLLOWING:

- 1. By-law No. 1358 concerning the selective collection of recoverable secondary materials, the yard trimmings collection, the food waste collection and the refuse collection shall be amended by adding, after section 66, the following section:
  - "Shared refrigerated refuse room
  - 66.1 Notwithstanding section 66, such establishments, included within an integrated commercial project and having a surface area of less than one hundred and fifty square meters (150 m2), may store their residual materials in a common refrigerated refuse room. All common refrigerated refuse room must be designed in accordance with paragraphs 1 to 5 and 7 to 10 of article 68 and maintained at a constant temperature ranging from 2°C to 7°C."
- 2. This by-law shall come into effect according to law.
