

ADOPTION OF BY-LAW NO. 1469 CREATING A FINANCIAL RESERVE TO FINANCE MAJOR EXPENSES AND THE REPLACEMENT OF THE ROYALMOUNT FOOTBRIDGE

ADOPTION PROCEDURE SUMMARY

NOTICE OF MOTION AND FILING: DECEMBER 12, 2023
ADOPTION OF THE BY-LAW: DECEMBER 14, 2023
COMING INTO EFFECT: JANUARY 1, 2024

WHEREAS the Royalmount Pedestrian Walkway Agreement was approved by Council resolution no. 21-10-05 on October 7, 2021 (the "Agreement");

WHEREAS the agreement concerns the construction of a footbridge located over Décarie Boulevard and connecting, among others, the Royalmount Project site to the De la Savane metro station so as to provide access to pedestrians, bicycles and persons with reduced mobility (the "Footbridge");

WHEREAS the Footbridge shall be accessible to the public and shall constitute a municipal infrastructure of Town of Mount Royal and a pedestrian public way;

WHEREAS under the Agreement, all current construction, maintenance and upkeep expenditures for the Footbridge are assumed exclusively by the owners of some of the taxable immovables located in the Project;

WHEREAS under the Agreement, all expenditures related to major repairs and the replacement of the Footbridge are assumed exclusively by the owners of some of the taxable immovables located in the Project;

WHEREAS it is appropriate and in the interest of the Town and its taxpayers to create a financial reserve for the purposes specified in the Agreement and specifically to create a reserve fund for financing expenditures related to major repairs to and the replacement of the Footbridge;

WHEREAS the By-law does not prohibit engagements by the parties to the Agreement and the parties undertake at all times to comply with the terms and conditions of the Agreement:

WHEREAS notice of motion was given on August 15, 2023, and the draft By-law was filed at the same Council meeting;

ON DECEMBER 14, 2023, COUNCIL ENACTED THE FOLLOWING:

- 1. The preamble shall form an integral part hereof.
- 2. A financial reserve shall be created hereunder for the purpose of creating a reserve fund for financing major repairs to and the replacement of the Footbridge.
- 3. The goal of said fund shall be to simplify, ensure and perpetuate the mechanism for collecting the amounts required under section 2 from the owners of the buildings described hereinbelow in order to preserve, to their benefit and that of all users, the active transportation facility that is the Footbridge and any equipment intended to encourage the use of active transportation to and from the immovables concerned.
- 4. In view of its nature, the reserve shall be constituted for an indefinite period.
- 5. The planned amount of said reserve is estimated not to exceed \$26,500,000 in constant dollars, with fiscal 2023 as the reference period.

6. To be able to appropriate the monies necessary for constituting the financial reserve, the reserve shall be constituted of sums raised through a special tax included in the budget for this purpose and imposed on all the taxable immovables in the sector of the Town described in Schedule A attached hereto and forming an integral part hereof, of any grant or other form of donation that is not reserved for a purpose other than those for which the reserve is created and of sums from the general fund appropriated for the purpose by Council, if appropriate.

The Town shall annually appropriate to the financial reserve all interest generated by the reserve.

- 7. Under the Agreement, the amount of this special tax and of the corresponding annual contribution from the owners of the taxable lots shall be based on a forecast of the need for major repair or replacement work on the Footbridge, including any indirect or professional costs, after consulting with the Maintenance Committee formed under the Agreement.
- 8. If applicable, any surplus of revenue over expenditures shall remain in the reserve for future use.
- In the event the reserve is abolished, the reserve's surplus of revenue over expenditures shall be used for the purposes of maintenance, upkeep, major repairs or replacement of the Footbridge.
- 10. The administrative arrangements relating to the use and management of the reserve fund under the Agreement shall be applicable at all times.
- This by-law enters into force according to the Law.
