- ☐ CD4 Certificate\* (issued by the Ministry of Environment and Fight Against Climate Change) – **Only required for contractors performing treatment and maintenance of lawns, trees and shrubs**

Note: It is the responsibility of the applicant to ensure that he has an insurance policy for each of his vehicles, as well as a liability insurance for the company.

1. Treatment: Any pesticide application method (see the definition of the term *pesticide* in section 2 of By-law No. 1436-1. This includes spreading, watering and sprinkling, spraying of gas, granules, powders and liquids and all other forms of application or discharge
